Purpose

The purpose of the Public Hearing is to consider an Application, designated as BZA022017, filed on September 11, 2017 by Rockford Homes Inc. of 999 Polaris Parkway, Columbus, OH, 43240. The Applicant is requesting approval for variance of Conditional Use for temporary model home with office and parking lot at 5544 and 5532 Whitestone Trace, Powell, OH, 43065, Lot 6915 and 6914.

Begin Hearing

Applicant, Corey Theuerkauf with Rockford Homes is asking for variance of Conditional Use for temporary model home with office and parking lot. The details regarding the model home with office and parking lot including hours of operation, as well as other details are given in the provided Application.

Questions from the Board

Mr. Kipfer asked about the hours of operation. Mr. Theuerkauf said the hours are as listed on the picture of the sign in the Application. Monday-Wednesday 12:00-7:00pm, Saturday 12:00-5:00pm, Sunday 12:00-6:00pm. Mr. Kipfer also asked what the dimension were in the parking lot. Mr. Theuerkauf stated that he did not have the actual dimensions with him. Mr. Theuerkauf added that he knew six spaces were required and he went over the location of the spaces with the Board. The Application also includes one handicap parking spot with loading area. The parking lot is the standard parking lot used for Rockford model homes. Mr. Kipfer wanted to confirm that the dimensions were to code. Mr. Theuerkauf said the other parking lots that they have done include Olentangy Falls East off of Hyatts road, Harvest Point, North Farms in Orange Township.

Mr. Theuerkauf asked how long the time frame was for the model home. Mr. Theuerkauf was told the time frame is 90% of home completion. The Conditional Use is for Rockford Homes. Rockford Homes has 120 units in the development, so the time frame would be 90% completion of Rockford Home’s 120 units.
