## Zoning Permit Process

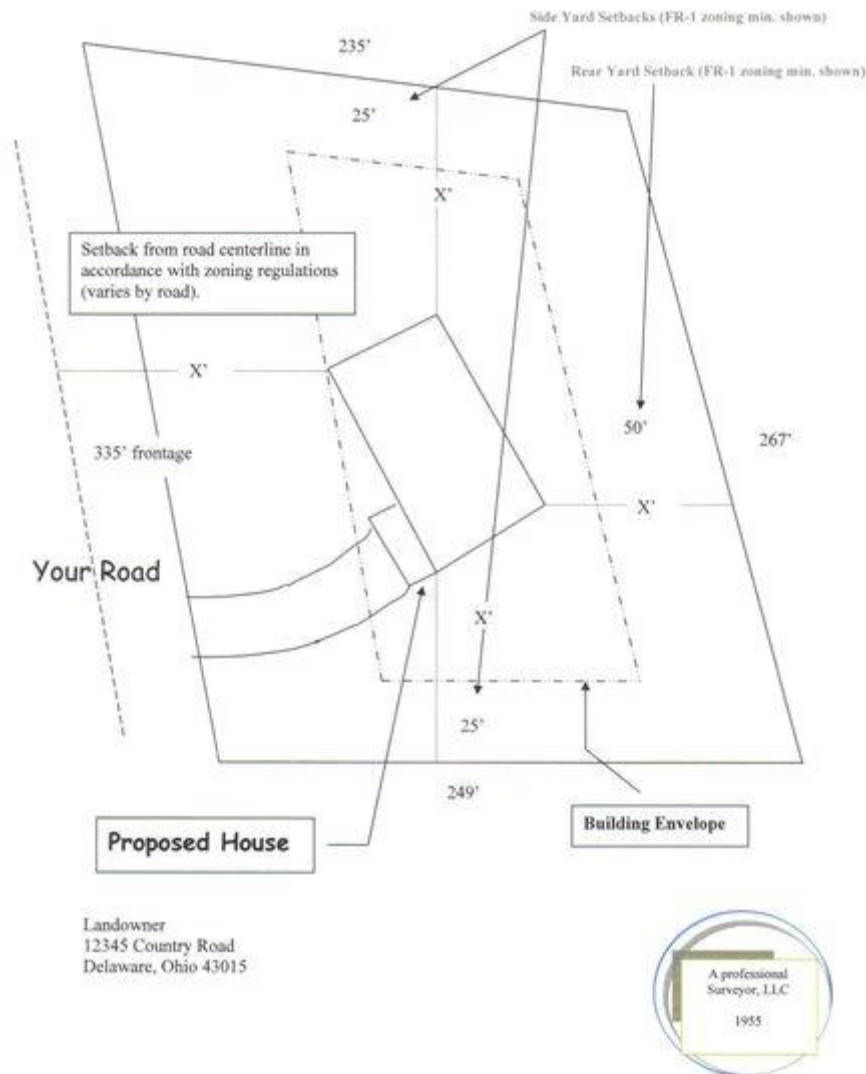
This is a Zoning Application/Permit ONLY. You will need to go to the Delaware County Building Dept. for your building permit and their inspections.

Below is an outline of the process to obtain a zoning permit in Concord Township. Completed Zoning Application with:

1. **One** plot site plan on **letter/legal sized paper** (8 ½ x 11 or 8 ½ x 14) showing the name and address of the property owner and all property dimensions and setbacks of structures.
2. **One** set of floor plans on **letter/legal sized paper** (8 ½ x 11 or 8 ½ x 14) showing floor plans of all finished living area, plus garages and covered porches, decks, carports, accessory buildings, etc.
3. **One** copy of your Health Permit if using on-site sewage treatment.
4. **One** copy of Driveway Permit from the Delaware County Engineer's Office.
5. **Check made payable to Concord Township Trustees**, according to the Concord Township Fee Schedule.
6. Zoning Certificate is good for one (1) year after issue date.
7. All new commercial structures require a sign-off from the Concord Township Fire Department.
8. A letter from the Delaware County Health Department indicating they have approved your construction plan is required before any permit for zoning is issued or prior to submitting to Delaware Code Compliance.

**THE FOLLOWING ITEMS MAY APPLY TO THE ISSUED PERMIT**

- Call before you dig-Ohio Utilities Protection Service – 800-362-2764.
- Trash and other waste must be contained on-site and disposed of regularly.
- Delaware County Code Compliance approval may be required prior to construction – 740-833-2200.
- A Work in the Right-of-Way permit may be required.
- Building/property must be identified with street numbers in accordance with the Concord Twp Zoning Resolution.
- Non-Residential use of the improvement is prohibited, in accordance with the Concord Twp Zoning Resolution.
- Human occupancy of the improvement is prohibited, in accordance with the Concord Twp Zoning Resolution.

IF CONSTRUCTION DOES NOT BEGIN WITHIN SIX (6) MONTHS OF THE ISSUANCE DATE OF THE PERMIT, THE PERMIT IS NO LONGER VALID. Changes to plans may require a revised or new permit. This permit is valid for twelve (12) months unless otherwise stated in the provisions sections above or unless otherwise extended after issuance via written consent of the concord township ZONING INSPECTOR OR HIS/HER DESIGNEE.
