

RECORD OF PROCEEDINGS
CONCORD TOWNSHIP BOARD OF TRUSTEES

The Concord Township Board of Trustees held a special meeting on Saturday, September 6, 2025 at 9:00 a.m. at the Concord Township Community Building, 6385 Home Road, Delaware, Ohio. Chairman Bart Johnson called the meeting to order at 9:22 a.m. The roll was called: Jason Haney-present, Joe Garrett-present, Bart Johnson-present.

Trustee Johnson stated the purpose of the meeting was vote to reaffirm Resolution 22-0323-1, creating a Tax Incentive Review Council (TIRC) for the Buckeye Valley Schools area in Concord Township, in accordance with ORC 5709.85. The TIRC Board is to consist of the Delaware County Auditor, the three Concord Township Trustees, a Buckeye Valley Local School District Designee (Treasurer Kelly Ziegler), and a Delaware Area Career Center Designee (Treasurer Chris Bell). Mr. Johnson moved and Mr. Haney seconded to approve the designated members of the TIRC Board created under Resolution 22-0323-1. Vote: Haney-yes, Garrett-yes, Johnson-yes.

In addition, a TIRC also needs created for the Tax Increment Financing (TIF) area of Dublin City School District in Concord Township under Resolution 23-1025-5. This TIF area currently includes Painter Farms Incentive District 1, 2, 3, 4, 5, 6, 7, and 8. Mr. Garrett moved and Mr. Haney seconded to adopt Resolution 25-0906-1 to approve the creation of a TIRC in accordance with ORC 5709.85. This TIRC Board will consist of the Delaware County Auditor, the three Concord Township Trustees, a Dublin City Schools Designee (currently Treasurer Brian Kern), and a Tolles Career & Technical Center Designee (currently Treasurer Tammy Woods). Vote: Haney-yes, Garrett-yes, Johnson-yes.

With no further business, Mr. Garrett moved and Mr. Haney seconded to adjourn. Vote: Haney-yes, Garrett-yes, Johnson-yes. The meeting was adjourned at 9:58 a.m.
